How does the new operator work in JavaScript?

In the specific case of throw, `throw new()` is a shorthand for `throw new Exception()`. The feature was introduced in c# 9 and you can find the documentation as Target-typed new expressions.



Is JavaScript's "new" keyword considered harmful?

It is NOT 'bad' to use the new keyword. But if you forget it, you will be calling the object constructor as a regular function. If your constructor doesn't check its execution context

then it won't notice that 'this'

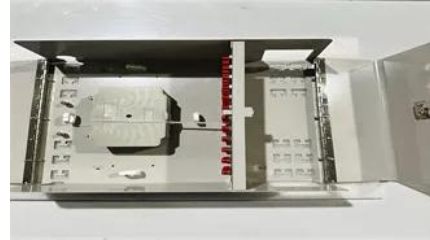
