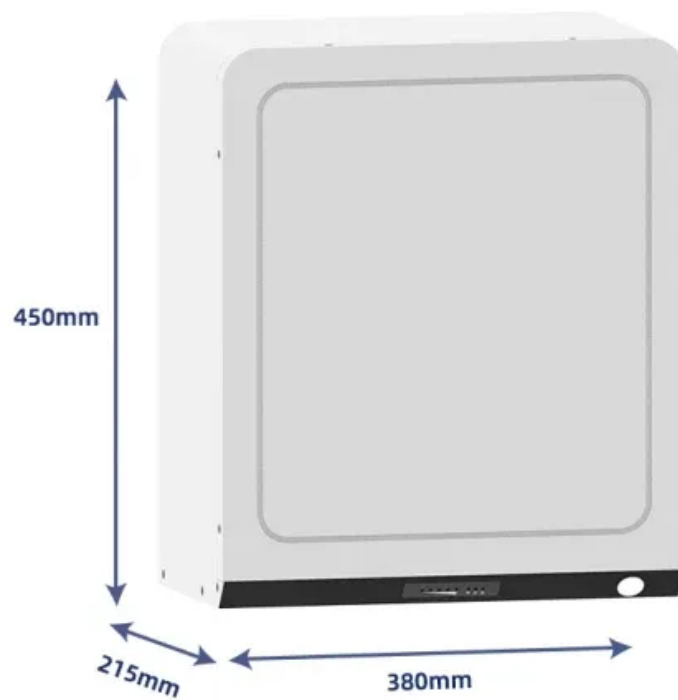

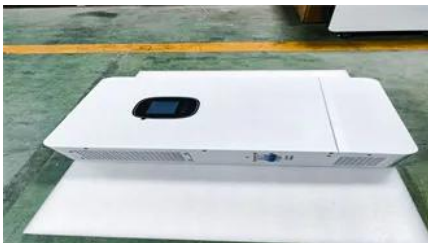

The difference between DO and DOES is not difficult to understand. DO is a verb and DOES is the third person singular of that verb in the present tense. Every other person in the conjugation uses DO.
